#### ORDER GRANTING APPLICATION TO INTERVENE

The County of St. Louis, Missouri (the "County") filed an Application to Intervene in Missouri-American Water Company's request for an Accounting Authority Order to track and record as a regulatory asset certain property tax payments assessed by the County and Platte County, Missouri. On July 27, 2017, the Commission issued an order setting a July 31, 2017 deadline for the filling of responses to the County's application. Since no responses were filed, the Commission will consider the County's unopposed Application to Intervene.

The Commission finds that the County has an interest in this matter that differs from those of the general public and that those interests may be adversely impacted by a final order in this matter. The Commission also finds that allowing the County to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the application.
