**MOTION TO SCHEDULE WORKSHOP**

**COMES NOW**, Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for the following Motion to Schedule Workshop, states as follows:

1. On Friday, June 15, 2018, Missouri-American Water Company (MAWC or Company) filed its P.S.C. Mo. No. 13, 1<sup>st</sup> Revised Tariff Sheet No. R. 65 (Revised R. 65) to replace the Original Tariff Sheet No. R. 65. Revised R. 65 has an effective date of August 14, 2018.

2. Revised R. 65 proposes to update a mathematical formula for calculating taxes on contributions in aid of construction made to the Company.

3. Because of the potential effects on a variety of stakeholders, Staff seeks stakeholder input on Revised R. 65.

4. Upon review of the Commission calendar, Staff recommends scheduling a workshop on July 19, 2018 in the Governor's Office Building, in Room 450 (Ballroom) at 10:00 a.m., wherein stakeholders are invited to provide input and comment upon Revised R. 65.

5. Staff further recommends interested stakeholders be invited to submit comments electronically in the EFIS case file until the date of the workshop.

6. Finally, Staff recommends that, the Commission's order opening the workshop also direct MAWC to file in the EFIS case file by July 5, 2018, an example of how the Revised R. 65 tariff formula is intended to work, as applied to a real-world scenario. Such a filing should help illustrate the operation of the tariff to potential stakeholders.

**WHEREFORE**, Staff respectfully moves the Commission to open a workshop docket, schedule a workshop on July 19, 2018 in the Governor's Office Building, Room 450 (Ballroom) at 10:00 a.m., direct Missouri-American to file an example of how the tariff is intended to operate, and invite any interested stakeholders to participate in the workshop.
