MOTION FOR RECONSIDERATION AND CORRECTION

COMES NOW YMax Communications Corp., ("Applicant" or "YMax"), by its undersigned counsel, pursuant to 4 CSR 240-2.160(4) and in support of this Motion for Correction states as follows:

- 1. This case was opened to consider an Application for Approval of an Amendment to an Interconnection Agreement between Applicant YMax Communications Corp. and Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri (AT&T Missouri) filed on December 19, 2007. The Interconnection Agreement between AT&T Missouri and YMax, which was approved by the Commission in Case No. CK-2007-0057, was referenced in the Application. It was an amendment entered into by the parties to that Agreement that was submitted for approval by the Commission; not a new Agreement. The Staff Recommendation filed on January 22, 2008, recommended that the Amendment to Agreement be approved.
- 2. The Commission issued its <u>Order Approving Interconnection Agreement</u> in this case on January 29, 2008. That <u>Order</u> is to take effect on February 8, 2008. The <u>Order</u> erroneously refers throughout to "Interconnection Agreement" rather than "Amendment to Interconnection Agreement". As there was no Interconnection Agreement pending before the Commission for approval, YMax concludes that these

references to "Interconnection Agreement" were in error, and requests the Commission correct this error in the manner it sees fit, either by issuing an Order Nunc Pro Tunc or other method as it may prefer; i.e., withdrawing the Order and issuing another. YMax believes a correction is necessary and in the best interest of accurate records of the Commission.

WHEREFORE, for the foregoing reasons, YMax Communications Corp. respectfully requests that the Commission correct the error that occurred in approving an "Interconnection Agreement" to reflect approval of an "Amendment to an Interconnection Agreement" between YMax and AT&T Missouri.
