Dear Mr. Woodruff:

On March 13, 2020, Confluence Rivers Utility Operating Company, Inc., (“Confluence Rivers”) filed a new sewer tariff (P.S.C. MO No. 13). The purpose of this filing was to implement the agreements set out in the *Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request* filed by the parties on February 10, 2020. The tariff sheets contained a proposed effective date of April 12, 2020 and were assigned Tracking No. YW-2020-0155.

On March 30, 2020, the Commission directed the parties to respond to a proposal to delay the effective date of the tariffs due to the COVID-19 pandemic and its related economic disruptions. Confluence Rivers recognized the issues raised by the Commission and responded affirmatively that it would voluntarily delay the effective date of the tariffs to July 1, 2020.

On April 8, 2020, the Commission issued its *Order Approving Unanimous Disposition Agreement and Small Company Rate Increase With Accompanying Tariffs*, wherein, among other things, it accepted Confluence Rivers’ offer to extend the effective date and made its order effective July 1, 2020. Accordingly, Confluence Rivers hereby extends the proposed effective dates tariff sheets filed under Tracking No. YW-2020-0155 from April 12, 2020, to July 1, 2020.
