## **ORDER CANCELING CERTIFICATE**

Issue Date: February 27, 2006 Effective Date: March 9, 2006 On February 9, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority of Officeplus Corporation of Missouri, a company that has been authorized by the Commission in Case No. TA-89-97, to provide shared tenant services at 111 Westport Plaza Drive, Suite 600, St. Louis, Missouri.

Staff filed a complaint against Officeplus for failure to file a 2002 annual report, Case No. TC-2004-0409. The parties reached a settlement with the Commission. Officeplus through counsel indicated it had ceased operations in Missouri. Furthermore, pursuant to a December 28, 1994, certificate of merger issued by the Secretary or State's Office, Officeplus Corporation of Missouri ceased to exist and "Officeplus Corporation" was the survivor of the merger. Office Corporation requested and received termination of its authority to do business in the State of Missouri on May 18, 2004.

Staff recommends that the Commission cancel the certificate of service authority to provide shared tenant services that has been issued to Officeplus Corporation of Missouri. Neither Officeplus Corporation of Missouri nor Officeplus Corporation has responded to Staff's motion. The Commission has the authority to cancel a certificate to provide shared tenant services pursuant to Section 392.410.5, RSMo Supp. 2005, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the statement of the certificate holder included in that motion, and on Officeplus Corporation of Missouri's failure to respond, the Commission finds that the certificate of service authority granted to Officeplus Corporation of Missouri shall be canceled.

## IT IS ORDERED THAT:

1. The certificate of authority to provide shared tenant services at 111 Westport Plaza Drive, Suite 600, St. Louis, Missouri, granted to Officeplus Corporation of Missouri, in Case Number TA-89-97, is canceled.

2. This order shall become effective on March 9, 2006.

3. This case may be closed on March 10, 2006.
