ORDER RESCHEDULING PROCEDURAL CONFERENCE

On April 5, 2023, the Commission issued an order in this matter scheduling a procedural conference to discuss proposed dates of an evidentiary hearing and the location of that hearing. On April 11, 2022, the Commission received an email communication from counsel for the Commission's Staff (Staff) explaining that Staff received a communication from the Complainant stating that she has started a new job that makes her unavailable for the originally scheduled procedural conference.

In its email, Staff requests that the Commission reschedule the procedural conference for any day after 3:30 p.m., and says that Staff, Complainant, and counsel for Raytown Water Company consent to such rescheduling.

The Commission will schedule a conference to discuss where the evidentiary hearing will be held, whether an evidentiary hearing via WebEx is appropriate, and any other matters relevant to procedures in this case. All parties must appear either by WebEx or by telephone.

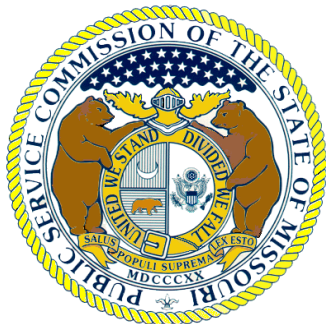
