ORDER DIRECTING RESPONSE TO REQUEST FOR MEDIATION

On March 6, 2023, Union Corporate Realty, LLC (Union Corporate) filed a complaint with the Commission against Missouri American Water Company (MAWC). On March 10, 2023, the Commission issued its *Notice of Small Formal Complaint and Order Directing Staff to Investigate and File a Report*, giving MAWC until April 9, 2023 to file its Answer. On April 10, 2023, MAWC filed *Missouri-American Water Company's Request for mediation In Lieu of Filing and Answer*. That request asks the Commission to appoint a presiding officer to this matter to mediate the dispute between MAWC and Union Corporate, and to toll all of the time limitations in this matter until completion of the mediation process.

Ten days have passed and Union Corporate has not filed a response to MAWC's request for mediation. The Commission will direct Union Corporate to respond to MAWC's request for mediation.

THE COMMISSION ORDERS THAT:

1. Union Corporate Realty, LLC, shall respond to MAWC's request for mediation no later than April 28, 2023.
2. This order shall be effective when issued.
