On June 22, 2018, the Office of the Public Counsel filed a petition asking the Commission to promulgate a rule pertaining to affiliate transactions of water corporations. Subsequently, on July 2, Public Counsel filed a motion asking the Commission for leave to withdraw its rulemaking petition.

Public Counsel explains that shortly after it filed its petition, the Commission's Staff independently filed motions in File Numbers AW-2018-0394 and WW-2018-0392 asking the Commission to open working cases to consider rules pertaining to the matters that are the subject of Public Counsel's rulemaking petition.
