**APPLICATION FOR INCLUSION OF FICTITIOUS NAME IN CERTIFICATION, AND  
MOTION FOR EXPEDITED TREATMENT OF THIS APPLICATION**

Comes now Comcast Phone of Missouri, LLC, d/b/a Comcast Digital Phone (“Comcast Phone-MO” or “Applicant”), by its undersigned counsel, and hereby applies pursuant to 4 CSR 240-2.060 for inclusion in its certificate of service authority the fictitious name “Comcast Digital Phone,” as set forth above. Further, Comcast Phone-MO moves for expedited consideration of this Application pursuant to 4 CSR 240-2.080(16). In support of its Application, Comcast Phone-MO states as follows:

1. Comcast Phone-MO filed an Application for a Certificate of Service Authority on May 13, 2005, under the name “Comcast Phone of Missouri, LLC d/b/a Comcast Digital Phone,” as set forth in the introductory paragraph to this Application. By order dated June 27, 2005, the Commission granted that Application and certificated Comcast Phone-MO as a telecommunications service provider in Missouri. However, the order does not include the d/b/a “Comcast Digital Phone” and by this Application, Comcast Phone-MO asks the Commission to issue an order including that fictitious name in the certification.

2. Comcast Phone-MO intends to use the requested fictitious name as part of its normal business operations in Missouri, both before and after the anticipated rollout of telecommunications service in the fourth quarter of 2005. Comcast Phone-MO has filed a tariff

which includes the d/b/a, and thus believes that it needs Commission approval of the inclusion of the d/b/a in its certification.

3. The proposed tariff, filed with tracking number JL-2006-0039, presently includes an effective date of September 13, 2005. Given the stated effective date of the tariff, and its plans to commence provision of service soon thereafter, Comcast Phone-MO requests that the Commission rule on this Application expeditiously, and no later than September 2, 2005. Although Comcast Phone-MO does not at present serve any customers in Missouri, it believes that Commission is needed by that date due to marketing and service rollout plans. Comcast Phone-MO does not believe that any Missouri customer or business will be injured by the granting of this Application by the requested date.

4. Comcast Phone-MO filed this Application and Motion for Expedited Treatment within a few days of learning of the absence of the d/b/a in the certificate, and that Staff believed that it is necessary for Comcast Phone-MO to seek Commission approval of the inclusion of the fictitious name in the certificate. There has been no unnecessary delay in filing this Application.

5. Attached hereto as Exhibit A is a copy of the Secretary of State's certification that Comcast Phone-MO has properly reserved the d/b/a "Comcast Digital Phone."

6. Consistent with 4 CSR 240-2.060(1)(K), Comcast Phone-MO does not have any pending action or final unsatisfied judgment or decisions against it from any state or federal agency or court which involves customer service or rates, which action, judgment or decision has occurred within 3 years of the date of application.

7. Consistent with 4 CSR 240-2.060(1)(L), Comcast Phone-MO does not have any overdue annual reports or assessment fees.

WHEREFORE, applicant Comcast Phone-MO respectfully requests that the Commission include in the certificate of service authority granted in the Docket the fictitious name "Comcast

Digital Phone” and for the reasons stated above, it grant this Application on an expedited basis, no later than September 2, 2005.






