On June 16, 2006, Big Island Water & Sewer Company filed an application with the Missouri Public Service Commission, pursuant to Section 393.170, RSMo 2000, requesting that the Commission grant it authority to provide water and sewer service to an unincorporated portion of Camden County, Missouri. The area to be served is a residential area on Big Island, which is located along the shores of the Big Niangua Arm of the Lake of the Ozarks.
