**ORDER DIRECTING NOTICE AND SETTING DATE FOR SUBMISSION**  
**OF INTERVENTION REQUESTS**

On June 16, 2006, Big Island Water & Sewer Company filed an application with the Missouri Public Service Commission, pursuant to Section 393.170, RSMo 2000, requesting that the Commission grant it authority to provide water and sewer service to an unincorporated portion of Camden County, Missouri. The area to be served is a residential area on Big Island, which is located along the shores of the Big Niangua Arm of the Lake of the Ozarks.

The Commission finds that notice of this application should be given to the general public and interested parties and that a date for intervention of proper parties should be set. The Commission's Data Center shall mail a copy of this notice to the County Commission of Camden County, and to the Department of Natural Resources of the State of Missouri. In addition, the Commission's public information officer shall make notice of this order

available to the media serving Camden County and to the members of the General Assembly representing Camden County.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party or governmental entity is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary.

**IT IS ORDERED THAT:**

1. The Missouri Public Service Commission's Data Center is ordered to serve notice as set out herein.
2. The Missouri Public Service Commission's information officer is ordered to serve notice as set out herein.
3. Any proper person wishing to intervene shall file an application to do so no later than July 10, 2006. Such applications shall be filed with:
