STAFF RECOMMENDATION ON TARIFF COMPLIANCE

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), through the undersigned counsel, and for its *Recommendation* respectfully states to the Missouri Public Service Commission (“Commission”) the following:

1. On September 2, 2009, Jerry Reed, d/b/a Woodland Acres Water System (“Woodland Acres”) filed revised tariff sheets pursuant to the Commission’s July 24, 2009 *Order Approving Unanimous Stipulation And Agreement*.

2. On September 21, 2009 the Commission issued its *Order Directing Filing*, allowing until August 28, 2009 for the Staff to file a recommendation on the tariff sheets compliance with the Commission’s July 24th *Order*.

3. Jerry Scheible, Staff Utility Regulatory Engineer, reviewed the tariff sheets filed in YW-2010-0134, and states that to the best of his knowledge, information, and belief, the revised sheets comply with the Commission’s *Order Approving Unanimous Stipulation And Agreement* and *Order Granting Motion to Amend Certificate of Convenience and Necessity*. See the *Affidavit Of Jerry Scheible* attached hereto.

4. The Commission has the authority pursuant to Sections 393.140 (11) and 393.150 RSMo (2000) to approve the proposed tariff sheets.

WHEREFORE, the Staff recommends that the Missouri Public Service Commission issue an Order approving the tariff sheets pending in Tariff File No. YW-2010-0134, effective October 2, 2009.


