#### STAFF RECOMMENDATION ON TARIFF COMPLIANCE

- 2. On September 21, 2009 the Commission issued its *Order Directing Filing*, allowing until August 28, 2009 for the Staff to file a recommendation on the tariff sheets compliance with the Commission's July 24<sup>th</sup> *Order*.
- 3.
