STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. On March 6, 2006, MultiBand, Incorporated, filed an Application under Section

392.410 RSMo 2005 Supp. requesting the Commission to grant it a Certificate of Service Authority to install, own, operate, control, manage and maintain shared tenant services in the State of Missouri. MultiBand has requested the waiver of certain statutes and regulations.

ate of Missouri. Multipune has requested the warver of certain success and regulations.

2. MultiBand is requesting authority to provide shared tenant services to apartments

located at 415 North Tucker Road, St. Louis, Missouri.

3. 3. Section 386.020(40) RSMo Supp. 2005 provides:

"Private shared tenant services" includes the provision of telecommunications and information management services and equipment within a user group located in discrete private premises as authorized by the commission by a commercial-shared services provider or by a user association, through privately owned customer premises equipment and associated data processing and information management services and includes the provision of connections to the facilities of local exchange telecommunications companies and to interexchange telecommunications companies.

Section 392.520.1 RSMo 2000 provides that the Commission has jurisdiction of shared tenant services, but "shall subject such services to the minimum regulation permitted by this chapter for competitive telecommunications services." Shared tenant services are also exempted from tariff filing requirements. *Id.*

4. The Commission issued an Order and Notice on March 14, 2006, directing parties wishing to intervene in the case to do so no later than April 3, 2006. AT&T Missouri filed an application to intervene on March 31, 2006.

5. In the attached Memorandum, which is labeled Appendix A, the Staff summarizes its review of the application and recommends that the Commission approve the application and grant MultiBand a certificate to provide shared tenant services.

6. When granting a certificate of service authority to provide shared tenant services, the Commission must determine whether certification is in the public interest. Section 392.440 RSMo 2000.

7. The Staff recommends that the Commission grant MultiBand the requested waivers, consistent with the Commission's treatment of other shared tenant services providers.

WHEREFORE, based upon the foregoing, the Staff respectfully recommends that the Commission enter an Order which grants MultiBand a certificate to provide shared tenant services in the state of Missouri and grants the requested waivers.
