MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE AUTHORITY AND TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and moves the Commission to open a case and cancel the Certificate of Service Authority it has granted to W2COM International, LLC, as well as the company's tariff. In support of its Motion, the Staff respectfully states as follows:

- 1. In January 2000 in Case No. XA-2000-379, the Missouri Public Service Commission (Commission) granted a certificate of service authority to W2COM International, LLC to provide intrastate interexchange telecommunications services. The Commission approved the company's tariff, P.S.C. Mo. Tariff No. 1, in the same case.
- 2. On April 13, 2006, W2COM International, LLC filed articles of cancellation of a foreign limited liability company with the Missouri Secretary of State as permitted by Section 347.161 RSMo. (Supp. 2005). As part of that filing, the company indicated that "[t]he limited liability company is not transacting business and surrenders its authority to transact business in the State of Missouri." Accordingly, the company's authority to do business in the state was cancelled as of that date. See Appendix A.
- 3. Mail sent to the address provided by the company has been returned to the Commission as undeliverable. See Appendix B. Moreover, the telephone numbers provided to the Commission by the company are no longer in service.

- 4. In keeping with indications that the company has ceased operations, W2COM International, LLC has not filed a 2005 annual report. The company owes no assessments. No customers have contacted the Commission to make complaints about W2COM International, LLC since the commencement of the Commission's Electronic Filing and Information System.
- 5. Because W2COM International, LLC no longer has authority to transact business in Missouri, because it does not provide telecommunications service in Missouri, and because it has apparently ceased to exist and cannot be contacted, the Staff recommends that the Commission issue an order canceling W2COM International, LLC certificate and tariff.
- 6. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo (Supp. 2005), which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. 1989).

7. Copies of this Motion are being served via registered mail upon the Missouri Secretary of State, as the Articles of Cancellation revoked the authority of the company's registered agent to accept service of process and indicated that service is to be made on the Secretary of State of Missouri instead. See also Section 347.161 ("A cancellation does not terminate the authority of the secretary [of state] to accept service of process on the foreign limited liability company with respect to causes of action arising out of the transactions of business in this state." Service is also being made upon the company at the address it has provided to the Commission.

WHEREFORE, the Staff recommends the Commission cancel the Certificate of Service Authority it has granted to W2COM International, LLC to provide intrastate interexchange telecommunications services in Case No. XA-2000-379, as well as the company's tariff, P.S.C. Mo. Tariff No. 1.




