**ORDER CANCELING CERTIFICATE**  
**AND ACCOMPANYING TARIFF**

Issue Date: February 6, 2008

Effective Date: February 16, 2008

On December 26, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Computer Network Technology Corporation (CNTC), a company that has been authorized to offer intrastate interexchange and nonswitched local exchange telecommunications services by the Commission.

In Case Number XA-2005-0015, the Commission granted CNTC a certificate to provide intrastate interexchange and nonswitched local exchange telecommunications services, restricted to dedicated private line services. CNTC's tariff, P.S.C. MO Tariff No. 1, was also approved.

Staff's motion states that counsel for the company indicated in a letter to the Secretary of the Public Service Commission, that CNTC is no longer providing telecommunications services in Missouri and requested the cancellation of the company's certificate and tariff. No formal complaints have

been filed against CNTC since the commencement of the Electronic Filing and Information System. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, P.S.C. MO Tariff No. 1, to provide intrastate interexchange and nonswitched local exchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and CNTC's request to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to Computer Network Technology Corporation, shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide intrastate interexchange and nonswitched local exchange telecommunications services, restricted to dedicated private line services, granted to Computer Network Technology Corporation, in Case Number XA-2005-0015, is canceled.
2. Computer Network Technology Corporation's tariff, P.S.C. MO Tariff No. 1, is canceled.
3. This order shall become effective on February 16, 2008.

4. This case may be closed on February 17, 2008.
