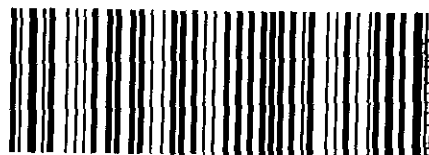

On June 7, 2005, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority to provide interexchange and non-switched local exchange telecommunications services that was granted to Global Communications Consulting Corp. in Case No. XA-2003-0188. Staff's motion indicates that letters mailed to Global Communications have been returned by the post office as undeliverable and that the company has not provided the Commission with a current address. Staff also reports that the company's phone number has been disconnected, and that Global Communications failed to file its annual report for 2004. Because of these failures, Staff asks the Commission to cancel Global Communications' certificate and accompanying tariff.

The Commission will order Global Communications to respond to Staff's motion. If the company fails to respond, Staff's motion may be granted without further notice.

**IT IS THEREFORE ORDERED:**

1. That Global Communications Consulting Corp. shall file a response to Staff's Motion to Cancel Certificate of Service Authority and Accompanying Tariff no later than July 8, 2005.

2. That the Commission's Data Center shall mail a copy of this order by certified mail, return receipt requested, to the address listed for Global Communications in the Commission's records, as indicated at the beginning of this order.


