ORDER DIRECTING FILING OF STAFF RECOMMENDATION

Effective Date: September 1, 2017

On July 20, 2017, the Missouri Public Service Commission (“Commission”) issued an *Order Granting Certificates of Convenience and Necessity and Granting Waiver*, which required Missouri-American Water Company (“MAWC”) to submit tariff sheets in compliance with the order to become effective prior to closing on the assets being purchased. On August 31, 2017, MAWC filed water and sewer tariff sheets under Tariff Tracking Nos. YW-2018-0027 and YS-2018-0028, respectively. MAWC also filed a *Motion for Expedited Treatment*, requesting that the proposed tariff sheets be approved to become effective on September 18, 2017, which is the date that MAWC intends to close on the transaction.

The Commission will direct Staff to file a recommendation regarding the proposed compliance tariff sheets and provide an opportunity for any party to respond or object to the *Motion for Expedited Treatment*. The usual response time will be shortened to facilitate issuing a final order at least ten days prior to the requested effective date.

THE COMMISSION ORDERS THAT:

1. No later than September 7, 2017, the Commission's Staff shall submit a recommendation regarding the compliance tariff sheets filed under Tariff Tracking Nos. YW-2018-0027 and YS-2018-0028 and the *Motion for Expedited Treatment*.
2. Any other party wishing to respond or object to the compliance tariff sheets or the *Motion for Expedited Treatment* shall do so no later than September 7, 2017.
3. This order shall become effective when issued.
