STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Recommendation to Approve Tariff Sheets* in this matter hereby states:

- 1. Missouri-American Water Company (MAWC) filed an *Application and Motion for Waiver* February 12, 2018, to purchase all of the water and sewer assets of the City of Lawson and requested Certificates of Convenience and Necessity (CCN) for the systems. Staff filed its *Recommendation* to approve the *Application* May 29, 2018 after a full investigation. The Office of the Public Counsel (OPC) filed a *Response to Staff Recommendation* June 25, 2018, recommending approval of the *Application*. The Commission approved Lawson's *Application* and granted it CCNs for the systems July 19, 2018.
- 2. Pursuant to Staff's *Recommendation* MAWC filed *Tariff Revisions* and a *Substitute Tariff* on July 20, 2018 and July 26, 2018, respectively. These tariff sheets all bear an effective date of August 19, 2018. Staff reviewed the tariff sheets and has determined that they are in compliance with the Commission's *Order*.
