MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of service authority to provide shared tenant services of Bradlie Business Service. (Company) and states:

- 1. On July 23, 1990, the Commission granted a certificate of service authority to the Company to provide shared tenant services in Case No. TA-90-257.
- 2. On May 9, 2019, the Company notified the Commission that it no longer wished to retain its registration to provide shared tenant services in Missouri in a designation on its Statement of Revenue filed for calendar year 2018 as non-case filing BSOR-2019-1945 attached here as Attachment A.
- 3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, Staff respectfully recommends the Commission cancel the certificate of service authority to provide shared tenant services in Missouri of Bradlie Business Service.
