**ORDER REGARDING CHANGING MEMBERSHIP OF THE RELAY
MISSOURI ADVISORY COMMITTEE**

On March 30, 2017, the Staff of the Commission filed a motion asking the Commission to approve the appointment of new members to the Relay Missouri Advisory Committee. Staff asks the Commission to appoint Robert Honan to fill the hard-of-hearing community position. Further, Staff asks that Scott Dollar (at-large position) and April Mason Donovan (deaf community position) be reappointed to their positions for a second term. Finally, Staff asks that Hampton Williams be recognized as an ex officio member of the board due to his appointment as Public Counsel.

The Commission will make the requested appointments.

THE COMMISSION ORDERS THAT:

1. Robert Honan is appointed to a three-year term for the Relay Missouri Advisory Committee's hard-of-hearing community position.
2. Scott Dollar's appointment to the Relay Missouri Advisory Committee's at-large position is extended for a second term of three years.

3. April Mason Donovan's appointment to the Relay Missouri Advisory Committee's deaf community position is extended for a second term of three years.

4. Hampton Williams is recognized as an ex officio member of the Relay Missouri Advisory Committee pursuant to his appointment as the Public Counsel.

5. This order shall become effective on April 16, 2017.

6. This file shall be closed April 17, 2017.


