<u>STAFF RECOMMENDATION TO CANCEL</u> <u>CERTIFICATE OF SERVICE AUTHORITY</u>

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation respectfully states:

1. The Staff recommends that the Commission issue an order to cancel the certificate of service authority of WWC License, LLC, d/b/a Cellular One Long Distance (WWC) to provide interexchange telecommunications services and accompanying tariff, Missouri P.S.C. No. 1. A copy of the staff recommendation dated June 27, 2005, is marked "Appendix A," attached hereto and made a part hereof.

2. WWC was granted a certificate of service authority to provide interexchange telecommunications services on December 1, 2000, in Case No. TA-2001-131. According to WWC's *Application of WWC License, LLC, d/b/a Cellular One Long Distance for Cancellation of Interexchange Certificate of Service Authority and Tariff*, filed June 20, 2005, WWC has no interexchange customers in Missouri; therefore, surrender of the certificate is not detrimental to the public interest. WWC will continue to provide Commercial Mobile Radio Service pursuant to its federal licenses. Staff records show that WWC owes no assessments or annual reports.

3. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410, RSMo Supp. 2004 which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).

WHEREFORE, Staff recommends the Commission issue an order canceling WWC's certificate of service authority to provide interexchange telecommunications services and accompanying tariff, Missouri P.S.C. No. 1.
