STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation, states as follows:

1. On October 21, 2010, Resort Operator Services filed a Ceasing Operation Statement (BCES-2011-0146) requesting the Commission cancel its certificate of service authority. Resort Operator Services was granted authority to provide interexchange telecommunications services on April 6, 1997 in File No. TA-97-325.

2. Because Resort Operator Services requested cancellation of its certificate and it is not providing services in Missouri, Staff recommends the Commission cancel the certificate.

3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

WHEREFORE, Staff recommends that the Commission cancel the Certificate of Service Authority for Resort Operator Services.
