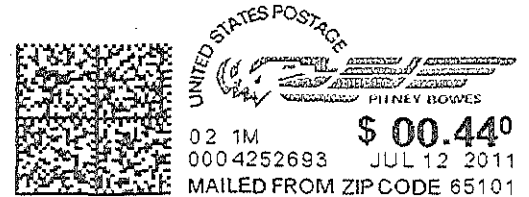

**ORDER CANCELING CERTIFICATE AND  
ACCOMPANYING TARIFF**

Issue Date: July 12, 2011

Effective Date: July 22, 2011

On June 21, 2011, the Staff of the Missouri Public Service Commission filed a motion requesting Asia Talk Telecom, Inc., d/b/a HelloCom, Inc. ("HelloCom") certificate of service authority and accompanying tariff to provide competitive intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XA-2006-0153, the Commission granted HelloCom a certificate of service authority to provide competitive intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that the Missouri Secretary of State Office administratively dissolved on April 26, 2010, for failure to file a correct and current annual report. Additionally, HelloCom's fictitious name registration expired on September 30, 2010, for failure to renew its registration with the Missouri Secretary of State.

In addition, HelloCom failed to file its 2010 annual report with the Commission. On June 2, 2011, Staff contacted HelloCom's previous counsel and was notified the company is no longer in business. Because the company can no longer conduct business in Missouri, Staff recommends that the Commission cancel the company's certificate of service authority to provide competitive intrastate interexchange telecommunications services, and the company's accompanying tariff.

On June 24, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than July 5, 2011. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Asia Talk Telecom, Inc., d/b/a HelloCom, Inc., shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide competitive intrastate interexchange telecommunications services granted to Asia Talk Telecom, Inc., d/b/a HelloCom, Inc., in File Number XA-2006-0153, is canceled.

2. Asia Talk Telecom, Inc., d/b/a HelloCom, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.

3. This order shall become effective on July 22, 2011.
4. This case may be closed on July 23, 2011.


