**STAFF'S SECOND STATUS REPORT  
AND REQUEST FOR EXTENSION OF FILING DATE**

**COMES NOW** the Staff of the Missouri Public Service Commission, and hereby respectfully submits this *Staff's Second Status Report and Request for Extension to File Staff Recommendation* in the above-captioned matter.

1. On January 20, 2015, TUK LLC filed Applications to obtain certificates of convenience and necessity to install, own, acquire, construct, operate, control, manage, and maintain water and sewer systems in Jefferson County, Missouri. This matter was consolidated with File No. SA-2015-0170 on February 3, 2015.

2. On February 13, 2015, the Commission ordered Staff to file a recommendation no later than March 12, 2015.

3. On February 20, 2015, Staff requested additional time to gather and process information and ask more questions if necessary. On March 3, 2015 the Commission ordered that Staff shall file its recommendation no later than May 15, 2015.

4. Since the last filing, Staff has visited the site numerous times and has been in communication with the owners and operators of TUK LLC, and is continuing to receive pertinent information. The Company is undertaking improvements to the water and sewer systems and currently has projects under construction. Staff only received final responses to most of its data requests near the end of April, and additional

information is forthcoming. Accordingly, Staff has determined that it requires an additional week to complete its recommendation. Therefore, Staff recommends the Commission order that Staff shall file its recommendation or a status report no later than May 22, 2015.

**WHEREFORE**, Staff prays the Commission grant an extension of time for Staff to file its recommendation or status report in this matter no later than May 22, 2015.
