Date: May 31, 2007

On August 30, 2006, Big River Telephone Company, L.L.C. (Big River) filed an application for a certificate of service authority to provide basic local exchange telecommunications services in exchanges that are currently being served by BPS Telephone Company (BPS) and for competitive classification (Case No. TA-2007-0093). The Commission issued its Report and Order on April 24, 2007, granting the requested authority and directing Big River Telephone Company, L.L.C. to file updated tariff provisions clearly identifying the services and rates offered to its customers for all of its telecommunications services and correcting all deficiencies in its current tariff. Big River made two separate tariff filings, YL-2007-0855 issued on May 24, 2007 to become effective on June 23, 2007, and YL-2007-0861 issued on May 25, 2007 to become effective on June 24, 2007.

Big River's Tariff File No. YL-2007-0855 proposes to add the BPS exchanges of Bernie, Parma and Steele, to the list of exchanges that Big River serves. The tariff filings also make numerous other revisions such as correcting addresses, revising the Rules and Regulations Section to comply with Missouri PSC rules and statutes, updating the Table of Contents, adding Big River's Residential Digital Cable Package and Business Digital Cable Package offerings, updating the definition sections, and making text corrections. None of the proposed revisions affect existing customers' rates. The Staff believes that Big River is in compliance with the Commission's Report and Order with regard to updating its tariff and recommends that the Commission issue an order to approve the following tariff pages (Tariff File No. YL-2007-0855) to become effective on June 23, 2007:
