## SUPPLEMENTAL FILING TO HEARTLAND HEALTH'S MOTION TO AMEND CERTIFICATE OF SERVICE AUTHORITY TO PROVIDE SHARED TENANT SERVICES

COMES NOW Heartland Health ("Heartland"), by and through its attorneys, and moves that the Missouri Public Service Commission accept and approve the following supplemental filing as an amendment to Heartland Health's Motion to Amend its Certificate of Service Authority to Provide Shared Tenant Services within the State of Missouri. In support of its supplemental filing, Heartland respectfully states as follows:

- 1. Heartland re-alleges and re-avers each of the allegations contained in its Motion to Amend Certificate of Service Authority to Provide Shared Tenant Services, as though fully set forth herein.

- 4. Heartland provides health and medical services to the residents of Northwest Missouri.
- 5. Heartland Health currently has an action pending before the Missouri Public Service Commission, Case No. TC-2004-0390. On July 15, 2004, and effective July 25, 2004, the Commission entered a report and order that Heartland Health did not timely file its 2002 annual report.
- 6. Other than the aforementioned action, Heartland states that it does not have any other pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involves customer service or rates. No judgment or decision has occurred within three years of the date of this application. Heartland further states that no annual report or assessment fees are overdue.

WHEREFORE, Heartland respectfully requests the Missouri Public Service Commission grant an amendment to Heartland's Certificate of Service Authority to Provide Shared Tenant Services, granted in Case No. TA-94-188, by report and order dated March 15, 1994, to include Heartland's new Medical Plaza 2 building because the new building is part of Heartland's "discrete, private premises."
