Order to Show Cause

Issue Date: May 7, 2009

Effective Date: May 7, 2009

The Missouri Public Service Commission is ordering Advanced Telemnagement Group, Inc., ("Advanced") to show cause why the Commission should not issue an order of default against Advanced.

On March 30, 2009, the Commission's staff ("Staff") filed the complaint. On April 1, 2009, the Commission issued an order requiring Advanced to file an answer no later than May 1, 2009. As of the date of this order, Advanced has filed no answer. Such facts support the entry of a default against Advanced:

If the respondent in a complaint case fails to file a timely answer, the complainant's averments may be deemed admitted and an order granting default entered. [1]

Before the Commission takes action under that provision, Advanced may show cause why the Commission should not do so.

To show cause why the Commission should not dismiss the complaint, Advanced must respond to this order by filing an answer and showing why the Commission should accept it out of time and not enter an order of default. If Advanced does so, the Commission may schedule a hearing to gather evidence on which to decide the complaint. If Advanced does not comply with this order, the Commission may deem the allegations in the complaint admitted and decide the case on that basis.

THE COMMISSION ORDERS THAT:

1. Advanced Telemanagement Group, Inc., shall file an answer to the complaint no later than May 29, 2009, and show cause why the Commission should accept the late filing and not issue an order of default against Advanced.

2. This order shall become effective immediately upon issuance.
