## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: September 9, 2011

Effective Date: September 19, 2011

On August 23, 2011, the Staff of the Missouri Public Service Commission filed a motion requesting Conversant Technologies, Inc. ("Conversant") certificate of service authority and accompanying tariff to provide competitive intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XA-2009-0442, the Commission granted Conversant a certificate of service authority to provide competitive intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. MO No. 1, was also approved.

Staff states in its motion that Conversant sent the Commission a Ceasing Operation Statement which indicated that the company ceased operations and is no longer in providing service in Missouri. Conversant is not deficient in the filing of the Company's 2010 annual report or fiscal year assessments. Staff recommends that the Commission cancel the company's certificate of service authority to provide competitive intrastate interexchange telecommunications services, and the company's accompanying tariff.

On August 23, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than September 2, 2011. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Conversant’s request to cancel and Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Conversant Technologies, Inc., shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide competitive intrastate interexchange telecommunications services granted to Conversant Technologies, Inc., in File Number XA-2009-0442, is canceled.
2. Conversant Technologies, Inc.’s tariff, P.S.C. MO No. 1, is canceled.
3. This order shall become effective on September 19, 2011.

4. This case may be closed on September 20, 2011.
