## ORDER DIRECTING NOTICE

On July 16, 2010, CIMCO Communications, Inc., n/k/a Cap Capital, Inc. filed an application with the Missouri Public Service Commission requesting their certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri be cancelled. The Commission granted CIMCO a certificate of service authority to provide interexchange telecommunication service in the State of Missouri in File Number TA-98-128.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> The Commission finds that proper persons shall be allowed ten days from the issuance of this order to file a motion for hearing. Before acting on Cap Capital's application, the Commission will also require a recommendation from its Staff.

### THE COMMISSION ORDERS THAT:

1. Any party wishing to file an objection or request a hearing shall do so by filing a pleading no later than July 29, 2010, with:

2. Staff shall file its recommendation regarding CIMCO Communications, Inc.'s Application for approval to cancel its certificate of service authority no later than August 9, 2010.


