# ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: July 8, 2011 Effective Date: July 18, 2011

On June 21, 2011, the Staff of the Missouri Public Service Commission filed a motion requesting Network US, Inc. d/b/a CA Affinity ("CA Affinity") certificate of service authority and accompanying tariff to provide competitive intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number TA-2002-188, the Commission granted CA Affinity a certificate of service authority to provide competitive intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that CA Affinity's fictitious name registration expired on October 17, 2009 for failure to renew its registration with the Missouri Secretary of State. In addition, the Missouri Secretary of State Office administratively dissolved on August 25, 2010 for failure to file a correct and current annual report. Because the company can no longer conduct business in Missouri, Staff recommends that the Commission cancel the company's certificate of service authority to provide competitive intrastate interexchange telecommunications services, and the company's accompanying tariff.

On June 21, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than July 1, 2011. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Network US, Inc. d/b/a CA Affinity, shall be canceled.

#### IT IS ORDERED THAT:

1. The certificate of authority to provide competitive intrastate interexchange telecommunications services granted to Network US, Inc. d/b/a CA Affinity, in File Number TA-2002-188, is canceled.

2. Network US, Inc. d/b/a CA Affinity's tariff, P.S.C. Mo No. 1, is canceled.

3. This order shall become effective on July 18, 2011.
