**WITHDRAWAL OF MOTION TO CANCEL CERTIFICATE AND ASSOCIATED TARIFF**

**COMES NOW** the Staff of the Missouri Public Service Commission, and for its Motion states:

1. On March 26, 2007, the Commission granted a certificate of service authority to Mobilitie, LLC ("Mobilitie") to provide interexchange and non-switched local telecommunications services, restricted to providing dedicated private line services, in the State of Missouri in Case No. XA-2007-0299 and approved the tariff assigned tracking number YX-2007-0554.

2. On November 14, 2013, Staff filed its *Motion to Cancel Certificate of Service Authority and Associated Tariff* of Mobilitie for failure to comply with the annual reporting requirements.

3. On December 12, 2013, Staff filed the *Stipulation and Settlement Agreement* made between Staff and Mobilitie the terms of which would require Mobilitie to timely file its Annual Reports going forward and to remit a payment for the Missouri Public School Fund of One Thousand Dollars (\$1000.00).

4. On January 3, 2014, the Commission filed its *Order Approving Unanimous Stipulation and Agreement* made between Staff and Mobilitie. Since that time, Mobilitie has complied with all of the terms of that *Stipulation and Agreement*.

As such, Staff withdraws its request that the Commission cancel the certificate and associated tariff of Mobilitie, LLC.

5. Rule 4 CSR 240-2.116 (1) allows an initiating party to dismiss a case without an order of the Commission at any time prior to the filing of testimony or the offering of oral evidence. The parties have neither pre-filed testimony nor offered oral evidence in this matter.

**WHEREFORE**, Staff withdraws its Motion and requests the Commission issue an Order to close this case.
