**MOTION TO CANCEL CERTIFICATE OF
SERVICE AUTHORITY AND TARIFF**

COMES NOW the Staff of the Missouri Public Service Commission and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of interexchange service authority in Missouri of Farm Bureau Connection ("the Company) and states as follows:

1. On December 2, 2005, the Commission granted a certificate of interexchange service authority to the Company in Case No. XN-2006-0191. It has an existing approved tariff with a tracking number YX-2006-0336.

2. On November 15, 2013, the Staff attempted to contact the Company after earlier failed attempts (see the attachment). The Company failed to file an annual report or pay any assessment to the Commission. The Staff believes that the Company no longer provides telecommunications services in Missouri.

3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel the certificate of service authority of Farm Bureau Connection to provide interexchange telecommunications service in Missouri as well as its tariff.
