On September 30, 2016, Total Call International, LLC ("Total Call") filed a notice of cancellation requesting the Commission cancel its certificates of service authority and any existing tariffs.

In Case Number TA-2001-510, the Commission granted Total Call a certificate to provide interexchange telecommunications services.

The Commission will direct its Staff to review the request and file a recommendation regarding the cancellation of Total Call's certificate of service authority and accompanying tariffs.
