On May 4, 2017, the Staff of the Missouri Public Service Commission filed a motion explaining that National Directory Assistance, LLC's ("National Directory") has asked that its certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri be cancelled. Staff asks the Commission to cancel that certificate and tariff. The Commission granted National Directory a certificate of service authority to provide interexchange telecommunication service in the State of Missouri TA-2002-476.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
