STATUS UPDATE

COMES NOW the Staff of the Missouri Public Service Commission and states as follows:

1. On May 22, 2017, Staff filed a Motion asking the Commission to cancel the certificate of service authority of Airnex Communications, Inc. due to a failure of Airnex to file Statements of Revenue and Annual Reports for the past two fiscal years. On June 7, 2017 the Commission issued an *Order* to cancel Airnex's certificate of service authority, but on June 13, 2017, Staff filed a *Motion to Suspend Cancellation* asking the Commission to permit Airnex time to file the necessary paperwork and assessments.

2. Airnex contacted Staff June 2, 2017, to discuss prevention of Staff's requested cancellation. Since that date Staff has received Airnex's delinquent Annual Reports and its delinquent Statements of Revenue, however, one copy of its Statement of Revenue is incomplete. Airnex has assured Staff it will receive its delinquent assessment payment, but to date Staff has not received this item.

3. Staff asks the Commission to hold this docket suspended until July 14, 2017, to permit Airnex an additional two weeks to provide Staff the necessary documentation and payment. If Staff has not filed an update by July 14 reflecting receipt of the necessary items, Staff asks the Commission to either permit its original *Order*

Cancelling Certificate and Accompanying Tariff to go into effect or to issue a new order in the alternative.

WHEREFORE, Staff respectfully prays the Commission will accept this *Status Update*; permit its *Order Cancelling Certificate and Accompanying Tariff* to remain suspended until July 14, 2017, pending Staff's update; issue a new order or permit the Commission original *Order Cancelling Certificate and Accompanying Tariff* to go into effect if Staff's update is received by July 14, 2017; and grant such other relief as the Commission finds just in the circumstances.
