
Dear Mr. Roberts:

**FIRST AMENDED REQUEST FOR CANCELLATION OF CERTIFICATE**

COME NOW, James R. Estes and Sara S. Estes ("Estes"), by and through counsel, and hereby files their First Amended Request for Cancellation of Certificate, by which they request that the Commission cancel the Certificate of Authority to Provide Shared Tenant Services within the State of Missouri (the "Certificate") issued in Commission Case No. TA-91-392, and in support of such request, state as follows:


1. By Report and Order effective October 11, 1991, the Commission granted Estes's request for the Certificate under which the Estes's were granted authority to provide shared tenant services ("STS") to tenants in three buildings identified in said Order, all pursuant to Sections 392.440 and 392.520, RSMo.
2. Pursuant to the Certificate, Estes provided STS to tenants in such buildings.
3. Subsequently, such tenants or subsequent tenants have obtained all telecommunications service directly from the local telecommunications provider, and Estes has ceased to provide STS to such tenants and has no plans to provide STS in the future.
4. Estes is therefore not acting as a public utility within the State of Missouri, and is not providing any public utility services, including STS.

5. Estes therefore hereby requests that the Certificate be cancelled, and that Estes thereby be relieved of any reporting, assessment, or other requirements previously imposed upon Estes pursuant to the Certificate.

WHEREFORE, Estes prays for the Commission's Order canceling the Certificate and thereby relieving Estes of any reporting, assessment, or other requirements previously imposed upon Estes thereby.
