On March 22, 2005, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority to provide interexchange telecommunications services that was granted to Global Crest Communications, Inc. d/b/a Dimensions in Case No. TA-2001-568. Staff's motion indicates that Global Crest failed to file its annual report for 2003. Furthermore, Staff indicates that the Missouri Secretary of State revoked Global Crest's certificate of authority to do business in Missouri on January 14, 2002. Staff also reports that Global Crest has failed to provide the Commission with a current address. Because of these failures, Staff asks the Commission to cancel Global Crest's certificate and accompanying tariff.

The Commission will order Global Crest to respond to Staff's motion. If Global Crest fails to respond, Staff's motion may be granted without further notice.

Staff's motion indicates two addresses at which Global Crest might be reached. The Commission will order its Data Center to mail this order to both addresses by certified mail, return receipt requested.

**IT IS THEREFORE ORDERED:**

1. That Global Crest Communications, Inc. d/b/a Dimensions shall file a response to Staff's Motion to Cancel Certificate of Service Authority and Accompanying Tariff no later than April 22, 2005.
2. That the Commission's Data Center shall mail a copy of this order to both addresses indicated at the beginning of this order by certified mail, return receipt requested.
3. That this order shall become effective on March 23, 2005.
