#### ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: November 9, 2006 Effective Date: November 19, 2006 On October 24, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and tariff of Globcom Incorporated, a company that has been authorized to offer interexchange telecommunications services by the Commission.

In Case Number XA-2003-0483, the Commission granted Globcom a certificate to provide interexchange telecommunications services. The company's tariff, PSC MO. TARIFF No. 1, was also approved.

Staff's motion states that Globcom failed to file its annual registration report according to the Missouri Secretary of State's Office, and its authority to do business in the State of Missouri was revoked on March 30, 2004. On May 16, 2005, the Company's registered agent resigned.

As further indications that the Company has ceased to exist, Globcom has not submitted a 2005 annual report or a fiscal year 2007 statement of revenue to the Commission. The phone numbers for the company are no longer operational and although mail sent to the company has not been returned, Staff was unable to obtain valid service of process upon the company in a penalty action the Commission's General Counsel brought against Globcom for failure to submit annual reports and pay assessments. The Cole County Circuit Court dismissed the case without prejudice.

Because Globcom no longer has authority to transact business in Missouri and because it has ceased to exist and cannot be contacted, Staff recommends that the Commission cancel the company's certificate of service authority and tariff to provide interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion to cancel the certificate and tariff and the company's revocation to do business in the State of Missouri and the lack of response from the company, the Commission finds that the certificate of service authority and tariff granted to Globcom, Incorporated, shall be canceled.

#### IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Globcom Incorporated, in Case Number XA-2003-0483 is canceled.

2. Globcom Incorporated's tariff, PSC MO. TARIFF No. 1, is canceled.

- 3. This order shall become effective on November 19, 2006.
- 4. This case may be closed on November 20, 2006.
