## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 18, 2007 Effective Date: January 28, 2007

On January 4, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Business Options, Inc., a company that has been authorized to offer intrastate interexchange telecommunications services by the Commission.

In Case Number TA-96-321, the Commission granted Business Options a certificate to provide intrastate interexchange telecommunications services. In the same case, Business Options' tariff, Tariff MO P.S.C. No. 1, was also approved.

Staff's motion states that the company's president, Kurtis Kintzel, indicated in an electronic mail to Public Service Commission Counsel, David Meyer, that Business Options is no longer providing telecommunications services in Missouri and requested the cancellation of the company's certificate and tariff. Furthermore, Business Options has no customers using the service that was to

be provided under that name and does not intend to pursue that line of business. No formal complaints have been filed against Business Options since the commencement of the Electronic Filing and Information System, and any informal complaints or inquiries received have been closed. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, Tariff MO P.S.C. No. 1, to provide intrastate interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and the president of Business Options' request to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to Business Options, Inc., shall be canceled.

## IT IS ORDERED THAT:

- 1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Business Options, Inc., in Case Number TA-96-321, is canceled.
  - 2. Business Options' tariff, Tariff MO P.S.C. No. 1, is canceled.
  - This order shall become effective on January 28, 2007.

4. This case may be closed on January 29, 2007.
