ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 23, 2007 Effective Date: September 2, 2007 On June 7, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and the accompanying tariff of Robert Wheland d/b/a Media Concepts, a company that has been authorized to offer interexchange telecommunications services by the Commission.

In Case Number TA-94-289, the Commission granted Robert Whelan d/b/a Media Concepts a certificate of service authority to provide interexchange telecommunications services. The Commission also approved the company's tariff, P.S.C. Mo. Tariff No. 1.

Staff's motion states that they have unsuccessfully attempted to contact Mr. Whelan via telephone and U.S. Mail. Although the mail has not been returned as undeliverable, Staff has received no reply from Mr. Whelan. The annual reports covering 2002-2005 reflect Mr. Whelan d/b/a Media Concepts, Inc. received no telecommunications revenues. Staff verified that Media

Concepts, Inc. existed, but was "delinquent" with the Kansas Secretary of State's Office because no annual filings had been submitted.

In addition, Mr. Whelan has not submitted a 2006 annual report or Fiscal year 2008 statement of revenue to this Commission. No complaints have been filed against the company since the commencement of the Commission's Electronic Filing and Information System. Commission Rule 4 CSR 240-3/545(22) requires telecommunications companies to provide and maintain current contact information at the Commission. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, P.S.C. Mo. Tariff No. 1, to provide interexchange telecommunications services. Staff notes that if Mr. Whelan wishes to reapply for a certificate, he does not need to retain an attorney because he was doing business as an individual.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to Robert Whelan, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Robert Whelan d/b/a Media Concepts, in Case Number TA-94-289, is canceled.

2. Mr. Whelan d/b/a Media Concepts' tariff, P.S.C. Mo. Tariff No. 1, granted in Case No. TA-94-289, is canceled.

3. This order shall become effective on September 2, 2007.

4. This case may be closed on September 3, 2007.
