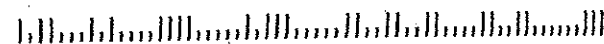

ORDER DIRECTING NOTICE

On November 1, 2010, the Staff of the Missouri Public Service Commission filed a recommendation supporting the cancellation of Resort Operator Services certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri be cancelled. The Commission granted Resort Operator Services a certificate of service authority to provide interexchange telecommunication service in the State of Missouri in File Number TA-97-325.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's recommendation is received, the Commission may cancel the certificate based on Staff's recommendation.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
