ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 31, 2017

Effective Date: February 10, 2017

On January 17, 2017, Total Access Telecom Inc. ("Total Access") filed notification for the discontinuance of services and requested the Commission cancel its certificate of service authority and accompanying tariff to provide telecommunications services in the State of Missouri.

In File Number XA-2012-0153, the Commission granted Total Access a certificate of service authority to provide telecommunications services in the State of Missouri, and approved its tariff. The Company's tariff, P.S.C. MO No. 1 was also approved.

On January 20, 2017, the Commission issued an Order Directing Staff to File a Recommendation. On January 30, 2017, Staff filed its motion to cancel certificate and tariff and stated that Total Access does not serve any customers in the State of Missouri. Staff recommends that the Commission cancel the company's certificate of service authority to provide telecommunications services and the company's accompanying tariff.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority


may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Total Access’s request and Staff’s recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to Total Access Telecom Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide telecommunications services granted to Total Access Telecom Inc., in File Number XA-2012-0153, is canceled.
2. Total Access Telecom Inc.’s tariff, P.S.C. MO No. 1 is canceled.
3. This order shall become effective on February 10, 2017.
4. This case may be closed on February 11, 2017.




