## ORDER DIRECTING STATUS UPDATE

Effective Date: July 13, 2017

On June 7, 2017, the Commission issued its Order Canceling Certificate and Accompanying Tariff, which directed Airnex's certificate of service authority and accompanying tariff be cancelled. On June 13, 2017, Staff filed a Motion to Suspend Cancellation. Staff explained it had been in contact with Airnex and recommended the cancellation of Airnex be suspended while Airnex supplies required documentation.

On June 30, 2017, Staff filed a Status Update stating the Commission has received all necessary paperwork, with the exception of one copy of its Statement of Revenue being incomplete. Staff asked for additional time to allow Airnex the opportunity to complete the document and submit its delinquent assessment payment. The Commission ordered Staff file an update by July 14. On July 13, Staff asked for additional time to allow Airnex time to complete the document and assessment payment, and proposes to file an update by July 28, 2017.

The Commission has withdrawn its order canceling Airnex's certificate and will take no further action regarding that certificate at this time. The Commission will direct Staff to file a status update.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file a status report no later than July 28, 2017.
2. This order shall be effective when issued.
