On November 2, 2017, TTI National, Inc. (“TTI National”) filed a letter requesting the Commission cancel its certificates of service authority and accompanying tariff.

In Case Number TA-96-423, the Commission granted TTI National a certificate to provide resold intrastate interexchange telecommunications services.

The Commission will direct its Staff to review the request and file a recommendation regarding the cancellation of TTI National’s certificate of service authority.

IT IS ORDERED THAT:

1. No later than November 27, 2017, the Staff of the Missouri Public Service Commission shall file a recommendation regarding TTI National, Inc.’s request to cancel its certificate of service authority.
