ORDER SETTING DEADLINE FOR FILINGS

On September 27, 2016, Osage Water Company, through its court-appointed receiver, filed a *Response to Staff's Motion for Default Determination*. The receiver states that he can file the 2013, 2014, and 2015 Annual Reports at issue in the complaint filed by Staff.

The Commission will grant Osage Water Company's request for an October 15 deadline to file its Annual Reports and set a deadline for Staff to file a status report. The Commission will not rule on *Staff's Motion for Default Determination* at this time.

THE COMMISSION ORDERS THAT:

1. No later than October 15, 2016, Osage Water Company shall submit its 2013, 2014, and 2015 Annual Reports to Staff and the Office of the Public Counsel.

2. No later than November 15, 2016, the Commission's Staff shall file a status report stating if Osage Water Company is in compliance with this order and if Staff wishes to pursue its complaint.

3. This order shall be effective when issued.
