COME NOW Consolidated Public Water Supply District No. 1 of Clark County, Missouri and the City of Canton, Missouri and pursuant to Section 247.172 RSMo. hereby file with the Public Service Commission of the State of Missouri their Addendum to Joint Application and, as grounds therefore, state as follows:

- 1. The parties hereto did on or about the 27th day of September, 2005 file a Verified Application for Approval of Territorial Agreement in the above captioned matter.
- 2. Thereafter, on December 9, 2007 the parties did along with the Staff of the Commission and the Office of the Public Counsel file a unanimous Stipulation and Agreement asking the Commission to approve the Territorial Agreement submitted.
- 3. The Commission did on or about the 22nd day of December, 2005 issue its Report and Order Approving Territorial Agreement effective January 1, 2006.
- 4. The Territorial Agreement aforesaid and all attachments thereto contemplate that nothing in the Territorial Agreement aforesaid is construed as an agreement, express or otherwise, to encroachment upon the service area of the Consolidated Public Water Supply District No. 1 of Clark County, Missouri not otherwise referred to the Territorial Agreement and all attachments thereto.

6. The parties agree that no further Territorial Agreements or transfer of service area and services shall be made between District or City without prior written approval of the State of Missouri, Public Service Commission.

WHEREFORE, Applicants request the Commission, pursuant to Section 247.172 RSMo. to approve by Report and Order the aforesaid Addendum to the Territorial Agreement previously submitted between the District and City.
