ORDER APPROVING TARIFF FILING IN COMPLIANCE WITH COMMISSION ORDER

On April 4, 2014, Missouri-American Water Company ("MAWC") filed compliance tariff sheets pursuant to the Commission's March 12, 2014 Order Approving Transfer of Assets and Certificate of Convenience and Necessity and Granting Waiver. The tariff sheets were assigned tariff tracking numbers JW-2014-0395, YW-2014-0396 and YS-2014-0394 and bear an effective date of May 4, 2014. MAWC also requested expedited treatment and approval of the proposed tariffs sheets on less than thirty days' notice. Two tariff sheets were substituted by MAWC on April 9, 2014.

On April 14, 2014, the Commission's Staff filed a recommendation that the Commission approve the compliance tariffs. No other party filed a response or objected to approving the tariff sheets within the time designated by the Commission. The Commission

has reviewed the tariff filings and Staff's verified recommendation and finds that the tariff should be approved with an expedited effective date. MAWC has demonstrated good cause for the expedited treatment since the compliance tariff sheets were filed pursuant to the Commission's order and are designed to establish rates for the Emerald Pointe area upon the closing of the transaction.
