**JOINTLY PROPOSED PROCEDURAL SCHEDULE**

**COMES NOW** the Staff (“Staff”) of the Missouri Public Service Commission (“Commission”), by and through counsel, and on behalf of Missouri-American Water Company (“MAWC”) and Office of Public Counsel (“OPC”), (collectively, “parties,”) states as follows:

1. The parties have agreed to the procedural schedule described below, and request that the Commission enter an order approving this schedule.

- **Filing of Direct Testimony:** Monday November 24, 2014.  
-should the parties not agree on stipulated facts, otherwise only oral argument shall be needed.
- **Issues List:** Tuesday November 25, 2014.  
-if case not resolved through Settlement,
- **Witness List:** Tuesday November 25, 2014.  
- should the parties not agree on stipulated facts, otherwise only oral argument shall be needed,
- **Position Statements:** Wednesday November 26, 2014.  
-if case not resolved through Settlement,
- **Hearing or Argument:** Monday December 1, 2014.  
-if case not resolved through Settlement,
- **Briefs:** Monday December 8, 2014.  
-if case not resolved through Settlement.

2. The parties request that the Commission reserve the day of December 1, 2014 for any necessary Hearing or Argument in this matter, if this matter is not resolved by a ruling on any Dispositive Motions or Settlement that may be reached and filed.

**WHEREFORE**, Staff respectfully submits this *Jointly Proposed Procedural Schedule*, on behalf of the parties, and requests the Commission enter an order (1) adopting this schedule and reserving December 1, 2014 for hearing or argument, if necessary.
