AMENDED STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and recommends that the Commission approve the tariff sheet Missouri-American Water Company (“Company”) filed on May 19, 2023.

1. On December 12, 2022, Missouri-American Water Company (“Company”) filed an Application for the Approval of an Agreement with the City of O’Fallon, Missouri (“City”) to Sell and Deliver Water for Resale and a Related Tariff Sheet, and on January 6, 2023, the City of O’Fallon, Missouri (“City”) filed a timely application to intervene in the matter.

2. On January 27, 2023, the Commission granted the City of O’Fallon’s Application to Intervene.

3. On April 27, 2023, Staff filed its Recommendation with the Commission and on April 28, 2023, the Company filed its response to Staff’s Recommendation.

4. On May 18, 2023, the Commission approved the Company’s application, and ordered the Company to file a tariff.

5. On May 19, 2023, the Company filed a compliance tariff sheet with an issue date of May 19, 2023 and an effective date of June 18, 2023. This tariff sheet was assigned tariff tracking number YW-2023-0205. Also on May 19, 2023, the Company moved the Commission to allow this tariff sheet to take effect with less than 30 days’

notice. The Company requests that the Commission order this tariff sheet take effect on June 1, 2023, or as soon thereafter as is practicable.

6. On May 19, 2023, the Commission ordered Staff to file a recommendation regarding the Company's compliance tariff by May 24, 2023.

7. After review, Staff determined that the following complies with the Commission's Order. Therefore, Staff recommends approval of:

P.S.C. MO. No. 13

2nd Revised Sheet No. RT 24 Cancelling 1st Revised Sheet No. RT 24

8. Staff does not object to this tariff sheet taking effect on June 1, 2023, or as soon thereafter as is practicable.

9. Staff attaches an affidavit to this pleading verifying its review.

WHEREFORE, Staff respectfully recommends the Commission approve the Company's tariff sheet, as listed in paragraph 7, to take effect on June 1, 2023, or as soon thereafter as is practicable.


